

FIRE EMERGENCY RESPONSE PROCEDURE

Ver.2 17.04.17

ANYONE OBSERVING FIRE SHALL RAISE ALARM, THEN NOTIFY THE QHSE EMERGENCY NUMBER Ext. 111 and 08038279550

ALL PERSONNEL (OTHER THAN TRAINED FIRE-WARDENS) ON HEARING THE ALARM SHALL:-

PROCEED IMMEDIATELY TO THE MUSTER POINT IN CALM AND ORDERLY MANNER FOR ROLL CALL.

HEAD QHSE ON BEEN NOTFY FIRE MUST IMMEDIATELY CONTACT THE FIRE SERVICES.

THE TRAINED FIRE TEAM SHALL ATTEMPT TO EXTINGUISH OR CONTAIN THE FIRE IF POSSIBLE WITH THE AVAILABLE FIRE EXTINGUISHER, ONLY IF IT IS SAFE TO DO SO.

POINTS TO NOTE WHEN MAKING EMERGENCY CALLS

- YOUR NAME AND EXACT LOCATION OF INCIDENT.
- BE CALM, DO NOT PANIC.
- MENTION THE CASUALTIES, IF THERE IS ANY.
- MAKE SURE THE OTHER PERSON DROPS CALL FIRST

• YOUR NAME & THE LOCATION YOU ARE CALLING FROM

• NATURE OF INCIDENT

• LOCATION OF INCIDENT

• NUMBER OF KNOWN CASUALITIES

• NATURE OF INJURIES (IF KNOWN)

NB: TO SEND PRELIMINARY INFO TO QHSE MGT

THE BASE RADIO STATION OPERATOR / SAFETY SUPERVISOR MUST IMMEDIATELY CONTACT THE SITE CLINIC AND AMBULANCE SERVICE AND COMMUNICATE THE FOLLOWING;

- NATURE OF INCIDENT
- LOCATION OF INCIDENT KNOWN CASUALTIES
- NATURE OF INJURIES (IF KNOWN)

THE CHSE WILL MONITOR SUITATION IN LIASION WITH THE CLINIC AND AS SOON AS DETAILS ON THE CASUALTY(S) CONDITION IS MADE KNOWN BY THE CLINC; THE CHSE SUPERVISOR WILL COMMUNICATE SAME TO CHSE MANAGEMENT
